**Grant Title:** The Academy of Natural Sciences of Philadelphia Undergraduate Research Fellowships

**Primary Purpose of Grants:** Ten week summer internships are offered for undergraduates, through the National Science Foundation's (NSF) Research Programs for Undergraduates (REU). The Academy's REU program is dedicated to training students in research based on the Academy's world-renowned collections in Botany, Ichthyology, Ornithology, Entomology, Malacology, and Paleontology as well as Library and Archives.

**Qualifications:** Applicants must be U.S. citizens or permanent residents and enrolled in a college or university (i.e., entering your sophomore, junior, or senior year after completing The Academy of Natural Sciences of Philadelphia's summer program). There is no actual application, but applicants must provide (1) a one-page statement of intent stating career goals, any prior research experience, choices of projects, and personal information, (2) transcript, and (3) two letters of recommendation.

**Amount and Term of Grants:** The Academy will pay for travel to and from Philadelphia, housing and expenses for supplies, field trips, and research. All students will live in dormitories or apartments adjacent to The Academy of Natural Sciences in the heart of the Museum district of Philadelphia. Each student will receive a stipend of \$350 per week.

**Grant Title:** African Bird Club Conservation Programme

**Primary Purpose of Grants:** The African Bird Club Conservation Programme supports small conservation projects in Africa. Since 1996, it has supported a wide variety of projects including training courses, research into threatened species and promotion and awareness of conservation issues in Africa. The Club aims to encourage as wide a range of ideas as possible. Many different types of project can be considered so long as there is a clear conservation objective. These could include: survey and research into African birds, educational projects or training courses, production of guides to the common birds of a country in local languages, interpretation material for nature reserves, and other ideas will be considered.

**Qualifications:** Conservation Award applicants must be normally a resident in Africa. Ideally, the requested grant from The African Bird Club should be a major part of the project budget. Requests for contributions towards academic fees will not be considered. However funding for field projects that are being carried out as part of an academic study may be considered if funding from the academic institution is not available. See website for Expedition Award criteria.

**Amount and Term of Grants:** Our current budget stands at £8000 per annum and the Club welcomes applications for conservation-based projects from individuals or institutions up to maximum of £850. The African Bird Club Expedition Award is an annual award of £1000 for larger, more ambitious projects.

**Funding Restrictions:** Applicants must be a resident of Africa. Ideally, the requested grant from ABC should be a major part of the project budget requests for contributions towards academic fees will not be considered. However funding for field projects that are being carried out as part of an academic study may be considered if funding from the academic institution is not available.

**Grant Title:** Zoo Keeper Grants in Zoology

**Primary Purpose of Grants:** The purpose of the AAZK, Inc. Research Grants Committee is to encourage and support research conducted by members in

zoological parks and aquariums. Through collaboration with scientists in other institutions, it is hoped that members will achieve continuing professional growth, and thereby increase the benefits to the zoological community.

**Qualifications:** Full-time keepers/aquarists in zoological parks and aquariums, who are professional members of AAZK, Inc. in good standing, and are eligible to receive grants. Researchers other than zoo keepers may participate in the funded studies. The principal investigator, however, must be a keeper/aquarist.

**Amount and Term of Grants:** AAZK, Inc. will award a grant up to \$1000 for a one (1) year period to an applicant interested in pursuing a specific research project. Two grants are awarded each year. The grant cycle runs from January 1<sup>st</sup> to December 31<sup>st</sup>.

**Funding Restrictions:** The committee will not fund any invasive biological studies, or any study that may cause an animal undue or prolonged discomfort or harm. Expenses that are not allowed include travel and telephone costs, animal purchases and wages for research participants. Grant recipients will be reimbursed for research expenses upon presentation of receipts. Only in unusual circumstances, and only with Board approval, will grant recipients be advanced funds. In such cases, receipts will be required as soon as they are available. Upon completion of the study, all equipment purchased with AAZK funds becomes the property of AAZK, Inc. and must be forwarded to the committee unless other arrangements have been approved.

**Grant Title:** ABC's William Belton Small Grants Fund

**Primary Purpose of Grants:** Bird conservation projects at sites identified by the Alliance for Zero Extinction (AZE) for the conservation of Critically Endangered (CR) and Endangered (EN) bird species in Latin America and the Caribbean will be given highest priority for support. Projects that address the conservation of Critically Endangered and Endangered bird species at other sites in the region will also be considered. Only projects fitting one of these two criteria will be eligible for funding. For a list of CR and EN bird species. **Grant Title:** Meacham Foundation Memorial Grant

**Primary Purpose of Grants:** The Meacham Foundation Memorial Grant was established in 1969, in memory of Tressa Meacham, to provide financial assistance to agencies for shelter expansion or improvements. Grant money must be used to increase and/or improve the quality of care given to animals.

**Qualifications:** Grants will be made only to animal care agencies duly incorporated and classified as 501(c)3 nonprofit organizations or public (local government) agencies. Agencies must also be current members of American Humane at the Agency Member level to qualify for a Meacham Foundation Memorial Grant.

**Amount and Term of Grants:** Grants may be awarded in any amount up to \$4,000.

**Funding Restrictions:** Meacham grants are awarded only for construction, capital improvement, or equipment that directly impacts the welfare of animals in the shelter. Meacham grants may not be used for supplementing an agency's

operating budget, reducing deficits, purchasing vehicles, or for routine maintenance.

**Grant Title:** American Museum of Natural History Grants

**Primary Purpose of Grants:** Modest short term awards are offered to advanced graduate students and postdoctoral researchers who are commencing their careers in the fields of zoology, paleontology, anthropology, astrophysics and earth and planetary sciences. Grants are available from a number of special funds: Frank M. Chapman Memorial Fund (ornithology, both neontological and paleontological), Lerner Gray Fund for Marine Research (marine zoology), Theodore Roosevelt Memorial Fund (North American fauna), and the Collection Study Grant Fund (Anthropology, Astrophysics, Earth and Planetary Sciences, Entomology, Herpetology and Ichthyology, Invertebrates, Mammalogy, Ornithology, Vertebrate Paleontology). Research projects need not be carried out at the American Museum.

**Qualifications:** Application requirements, eligibility, and other details vary among the grants. See website for details.

**Amount and Term of Grants:** Approximately 200 grants are awarded annually to meet modest financial needs not normally available from private foundations or granting agencies. Awards range from \$200-\$2,000 with an average of \$1,400.

**Grant Title:** American Ornithologists' Union Research Awards

**Primary Purpose of Grants:** The Josselyn Van Tyne Memorial Research Fund, Alexander Wetmore Memorial Research Fund, Margaret Morse Nice Fund, Donald L. Bleitz Fund, Herbert and Betty Carnes Fund, and AOU Research Grants Fund were established to provide research funds for student members of the American Ornithologists' Union or other members without access to funds from major granting agencies. The Van Tyne, Bleitz, and Research Grants funds provide support for research in all areas of avian biology. The Wetmore Memorial Fund supports research in avian systematics, paleo-ornithology, biogeography, and neotropical biology. Undergraduate students and individuals engaged in independent research (not associated with a university) may also apply for an AOU Research Award.

**Qualifications:** The Margaret Morse Nice Fund is designated to encourage ornithological research by female graduate students. In addition, research awards from the Carnes bequest to the AOU are available. As stipulated in Betty Carnes' will, recipients of this award must be females and non-smokers (i.e., have not smoked for at least the previous six months).

**Amount and Term of Grants:** The Committee will likely award about 28 - 30 grants in 2005. Awards are made in amounts up to a maximum of \$1,800.

**Funding Restrictions:** Padded budgets and requests for items that do not appear necessary will reduce the chances of your study being funded. Requests for salaries for assistants are appropriate only if you can convince the committee that volunteers are not available. Inappropriate requests for budget items include: routine living expenses, stipend or salary for yourself, travel to meetings, supplies and overhead expenses normally provided by your institution, and most requests for permanent equipment (e.g., binoculars, scopes, and camping equipment) unless these are to become property of the applicant's institution or the AOU. Also, for those applying via a university, indirect costs will not be provided.

**Qualifications:** 1. Proposals can be considered only from currently enrolled Ph.D. (Doctor of Philosophy) students at an accredited university within the Americas. The Americas include Canada, the United States, Mexico, the countries of Central and South America, and the Caribbean.

2. At least some portion of the student's proposed research must take place in—or be significantly and specifically relevant to—one or more national parks in the student's country of citizenship.

3. National parks are those protected areas officially recognized and identified as national parks by the national government of a country in the Americas.

4. Students enrolled in universities in the United States, regardless of citizenship, will compete in the US category.

5. Students enrolled in universities outside the United States but within the Americas will compete in the Americas category, regardless of citizenship.

6. Students must have completed a majority of their coursework, and be able to complete the proposed dissertation research within three years of receiving an award.

**Amount and Term of Grants:** For 2004, there are 8 scholarships – 4 from the U.S. and 4 outside the U.S. There are also 4 honorable mentions from throughout all of the Americas. Each winning student will be awarded a Canon National Parks Science Scholarship of US\$78,000 paid in two installments.
